1. *Enrollment Certification.* I hereby certify that I am a current high school student, enrolled in an agriculture course at the North Clackamas Land Lab and am a current FFA member. I also intend on enrolling in an ag course next year unless graduating from high school. If I drop out of the program, I must sell my animal and repay the loan within 30 days.
2. *Use Advance for Purchase.* To use the advance for the purchase and care of the animal described in the Project Information. Monies will not be used to pay off hours owed to the land lab for rent.
3. *Care for the Animal, Inspection.* To care for the animal in accordance with good and acceptable agricultural practices, including proper handling techniques.
4. *Sell the Animal and Remit Proceeds.* To sell the animal through the Clackamas County Junior Livestock Auction (if all auction requirements are met) and to remit the proceeds received from the sale of the animal to

North Clackamas FFA (Sabin Schellenberg Center) in an amount equal to the amount advanced to me plus any additional amounts that may have incurred within **14 days** of student's recipient of proceeds. To assure that the NCSA will receive the proceeds, I authorize them to notify any and all parties deemed necessary that I have agreed to remit the proceeds to North Clackamas FFA. I understand that even if I don't sell the animal through the Jr. Livestock Auction I will still be obligated to repay North Clackamas FFA within a reasonable timeframe.

5. *Notify North Clackamas Agriculture Instructors of Changes in Plan.* To notify the ag teachers within **10 business days** of any changes in plans affecting the showing and selling of the animal, or any changes in the project information. (Address or phone numbers)
6. *Project Books and Records.* (AET) To keep good, accurate and complete project records and to have records available upon request.
7. *Information Certified.* I hereby certify that the information contained above is true, complete and accurate as of the date I have signed this application. I understand that I am only allowed one outstanding project advance at a time.
